This Deed of public charitable trust is executed on this 30<sup>Th</sup> April 2025 by Mr. Manoj Kumar Devedi S/o Ramnath Devedi, aged about 48 years, resident of Gauraxani Santoshi Maa Path Sasaram Rohtas Bihar- 821115 herein after called the "Settler" (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representative of the one part).

Hereinafter jointly referred to as "Trustees" (Which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustees for the time being of these presents and their successors in office) of the other part.

Whereas if the trustees desire to co-opt another eminent personality as trustees for betterment of trust, they can co-opt. but the total number of trustees shall not be more than eleven

Whereas the Settler is desirous of establishing a trust for public charitable objects And whereas the trustees have, at the request of the Settler, agreed to act as the Settler trustee/ first trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents.

#### NOW THIS INDENTURE WITNESSES AS FOLLOWS:

1. That, in order to effectuate his aforesaid desire, the Settler has set apart and handed over to the trustees, a sum of Rs. 2100/- twenty one hundred (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

- a. To public newspaper, magazine, general and reproduce of arts, literature, science, craft and other allied works/ collections of works of arts for instruction and imparting useful knowledge.
- b. To eliminate Poverty, unemployment and starvation such as rural industries, home industries, small industry, small scale industries and efforts to ensure proper market conditions.

#### 6. PATRONS:

The governing body may according to such terms and condition as it shall decide from time to time admit as patrons those persons who are likely to help in furthering the objective and causes of the trust either through their professional knowledge and experience and /or through financial assistance.

#### 7. TRUSTEES:

- 7.1 All persons who have attained 18 years of age and have subscribed to the aims and objects of the Trust subject to the approval of the Governing Body will be entitled to be its Trustees. The Decision of the Governing body in this regard shall be final and binding.
- 7.2 The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.
- 7.3 The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

#### 8. TERMINATION OF MEMBERSHIP /TRUSTEE OF TRUST:

- 8.1 On death
- 8.2 On written resignation
- 8.3 On unsound mind
- 8.4 If found to be involved in any anti-social activities
- 8.5 If found guilty by means of anti-propaganda of the Aims and Objects of the Trust
- 8.6 If has not attended three consecutive meeting of the Governing Body without information
- 8.7 The Managing Trustee ( President ) of the Trust shall have the powers to expel/terminate a Any Trustee and member or members from the membership.



## 9. Governing Body of the Trust

The following persons shall form the Governing Body of the Trust.

1. Mr. Manoj Kumar Devedi : President cum Treasurer

Mrs. Neelam Tiwari : Secretary
 Mr. Ravi Bhushan Tiwari : Member

#### 10. MANAGING TRUSTEE

Mr. Manoj Kumar Devedi be designated as the MANAGING TRUSTEE (President cum Treasurer) of the trust. He will be at liberty for the time being to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.

#### 11. MEETINGS

- 11.1 The governing body will be held, at least, once in four months, notice of such meeting being given, at least, 15 days in advance. Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal, the President will have the casting vote.
- 11.2 The meeting of the Governing body shall be held at such time and place as the President may decide from time to time and all the meeting of the Governing Body shall be presided over by the President and in his absence by any one of the trustees. The annual general meeting shall be held not latter than six months after the closing of the financial year.

#### 12. ACCOUNTS

#### 12.1 Audit of Accounts:

A Chartered Accountant shall audit the accounts of the trust/society every year.

#### 12.2 OPERATION OF BANK ACCOUNT:

The governing Body have power to open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by the President or the Secretary (any one).

#### 12.3 SETTLEMENT OF ACCOUNT:

The Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

#### 14. POWERS AND FUNCTION OF OFFICE BEARER:


#### PRESIDENT:

- I. President shall preside over all the meeting of the trust and have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- II. President shall make disbursement in accordance with the direction of Governing Body and shall maintain accounts books minute register and manage daily routine correspondence.
- III. At the time of voting on any matter/subject if the total votes of the group of members happen to be equal in number; the President will have casting vote to decide the matter/subject.
- IV. President shall preside over all the meeting of the trust.
- V. At the time of voting on any matter/subject (except election) if the total votes of the group of members happen to be equal in number; the President has the power to cast an extra vote to decide the matter/subject.
- VI. President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- VII. President shall be convener of all the meetings and without his/her signature on the notice of meetings no meeting will be valid. It shall be his/her duty to see that the resolution at the respective meeting is implemented and given effect timely.
- VIII. President shall be at liberty to spend for the purpose of the Trust without sanction of the Managing Committee and to do all such other lawful things as incidental or conducive and expedient to the Trust.
- IX. While purchasing or acquiring any movable or immovable property on behalf of NGO the President will sign.

#### **SECRETARY:**

The Secretary shall enjoy all the powers of President in his/her Absence.

- I. Secretary will prepare the Membership Register as well as the Proceeding Register to record the minutes of the proceedings of the Governing Body Meetings and have them duly signed by the members who attend the meetings.
- II. Secretary shall make disbursement in accordance with the direction of Governing Body.



## FINANCE EXECUTIVE (Treasurer):

- 1. Treasurer shall maintain the accounts books and all money, which is received and/or paid by him/her on behalf of the trust.
- II. Treasurer shall make disbursement in accordance with the direction of Governing Body.

#### 15. FINANCIAL YEAR:

The financial year of the trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of every year.

#### 16. POWER TO SUE:

The trust may sue or be sued in the name of the Managing Trustee

#### 17. RECORD

The Governing Body will maintain a record of investments and disbursements besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the President of the next meeting.

#### 18. COMMITTEES:

Trust can permit its beneficiaries to elect committee or committees from among themselves for the smooth and efficient running of any particular branch of its activities. They can form rules and regulations for that particular branch under the given condition.

#### 19. ADMISSION FEE & SUBSCRIPTION:

The admission fee and subscription shall be as under unless otherwise revised by the managing committee of the Trust.

- a. Admission fee Rs.2100/= at the time of admission.
- b. Subscription of Rs.1100/= per year.
- c. Temporary Membership fee Rs. 500/-

#### 19. TRUST FUND:

- 19.1 That the trust fund may be augmented by the income from the fund and also by donations and other contribution from time to time.
- 19.2 That the trust fund shall not be applied for any purpose other than those specified in Para 5 herein above unless the other objects added to the trust objectives.
- 19.3 That the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.
- 19.4 In the matter of investment of Trust funds, the provision of section 20 of the **Indian Trust Act 1882** shall apply.

### 20. POWER AND FUNCTION OF THE GOVERNING BODY:

- **20.1** To fill the vacancy created by death or otherwise within three month of the occurrence of such vacancies by appointing any person as trustee.
- **20.2** The Governing Body of the trust will be empowered to open administrative office, Regional office, branch offices and central office of the trust in different states of India.
- **20.3** To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.
- 20.4 To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.
- **20.5** To provide grant in-aid and other financial assistance to voluntary organization and work as link between NGO's working in different parts of India and donor agencies and individual donors.
- **20.6** To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body of persons, trust, foundations, Govt. Departments or Funding agencies with or without conditions.
- **20.7** To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- **20.8** To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- **20.9** To take over, acquire, manage, control or amalgamate with any Institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- **20.10** To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- **20.11** To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- **20.12** To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes



- 20.13 To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.
- **20.14** To apply for grant-in-aid or donation to the Government Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- **20.15** The Governing body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.
- 20.16 Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the governing Body in such emergency meeting.
- 20.17 The Governing Body shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing contained shall be deemed to Trustees to spend the income or corpus of the trust for any purpose not authorized by these presents.
- 20.18 To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- **20.19** To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

#### 21. INVESTMENT:

We undertake that the society/trust/company would only invest its money in the forms or modes specified in section 11(5) of I.T. Act. We further undertake that the company/society/trust/ will insert relevant clause in desired format in MOA/Trust Deed, if required.

#### 22. AMENDMENT:

We undertake that the company/society/trust will not make any amendment in the object clause without the consent of concerned authority. We further undertake that the company/trust/society will insert the relevant clause in MOA/Trust Deed, if required.

## 23. IRREVOCABILITY:

We undertake that the trust/ company is irrevocable in nature and in case of winding up or dissolution of the trust, property of the trust/society/company shall be given or transferred to such other company/society/trust having objects similar to the objects of the trust/society/company. We further undertake that the trust/company will insert the relevant clause in desired format in MOA/Trust Deed, if required.

#### 24. BENEFICIARY:

We further undertake that the trustees or their relatives would not be beneficiary of the trust. The beneficiaries of the trust would be weaker section of the society/trust/company and the people generally required help and assistance in different facets of their lives.

#### 25. SEAL OF THE TRUST

Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.

#### 26. DISSOLUTION:

In the event of dissolution of the trust the funds / assets will be transferred only to some other trust / society having similar objectives after adjustment of liabilities.

In the Event of Dissolution of the Trust, the entire Society funds shall be realized and first be used for payment of liabilities of the trust.
